Frøome awarded 2011 Vuelta crown after Spain's Cobo gets doping ban

London: Eight years on, Chris Frøome has been crowned winner of the 2011 Vuelta a España after Spain's Juan Jose Cobo was stripped of the title following a doping violation. The now retired Cobo was found to have "abnormalities" in his biological passport between 2009 and 2011, prompting the International Cycling Union (UCI) to hand

him a three-year suspension last month.

The 38-year-old did not appeal the decision before the Court of Arbitration for Sport within the stipulated 30 days, paving allowing the UCI to award Frøome his seventh Grand Tour title.
